INTERNAL RULE

ARTICLE I

The distinctive title of the de association is:

ARTICLE II

The President is the head of the organ of the association convene and preside at meetings: he governs for the duration of his mandate together with his Board of Directors.

This charge is larger, should be entrusted to members of a recognized and well-proven zeal merit, and join a firm mind and informed all the sweetness of character necessary for such vital functions .

The President is specifically charged with the maintenance of the laws of the association in 1901 and implementing regulations. he must govern and lead with firmness and gentleness, but with caution.

he must fully ensure the accuracy of economic recoveries, and accountability towers annually.

In the discussion, the Chair may vote on the first or last, at its option. In case of equality of suffrage, he will give the deliberation at the next meeting if the case is likely to be delayed. If then the votes are still equal, the President has the casting vote.

ARTICLE III

The secretary is specifically responsible for the correspondence of the Association and send the letters. He focuses on the protocol of meetings receptions, deliberations and elections. Receptions and affiliations will also be signed by the members that have been received.

The secretary shall convene the members to the various meetings on the days and times agreed, indicating the agenda of the deliberations.

The secretary is also the keeper of the archives, for which he will pay particular obligation.

ARTICLE IV

The Treasurer is responsible for collecting membership fees, and all that is due to any reason whatsoever.

He will pay receipts and receipts and all expenses necessary for the smooth running of the Association.

However, he can not do these operations without the agreement of the President and his office.

At each ordinary or annual general meeting, will present the results verified by the officers, to its adoption and the meeting will give him Discharge.

ARTICLE V

Assistants of the various items may be appointed by the assembly, but will not occupy the respective positions if the holders are present.

The Vice President is the right arm of the President and can replace him in his absence.

he is also his direct advisor and should assist both in his management and in his authority.

ARTICLE VI

the polls

It is the rule that all major proposals are examined and different opinions that they generate discussed and adequately lit before holding the ballot and shall decide definitively.

There are two different ways to hold the polls:

1 - written by TICKETS: is usual in all elections.

2 - a simple YES or verbal NEGATIVE, when the President, after examining a proposal, collects the final vote.

This is the most appropriate in the deliberations, when dealing with an object that no significant consideration can obstruct the public vote.

For elections and deliberations is the plurality of votes will decide.

QUORUM BEING FIXED AT 80% OF THE MEMBERS PRESENT AT THE ASSEMBLY AND 50% REGISTERED MEMBERS

ARTICLE VII

Members

ORDINARY MEMBERS called those who regularly participate in the Assemblies and attend meetings regularly and accurately Pay the annual fee. They enjoy the decisive voice in all proceedings which they may be called.

The FREE ASSOCIATES are those which, by their home or their civilian occupations cannot be subject to the strict and permanent duties, they will be, however, obliged to attend the Meeting ORDINARY or EXTRAORDINARY.

The HONORARY MEMBERS are those to which we want to give that title in recognition of services rendered. They have only an advisory capacity in the deliberations.
